

#### **HOW TO EARN THE CHARTER?**

#### 1. Become the CFA Programme Candidate

The entrance requirements for CFA Programme candidacy:

- ✓ Completed a bachelor's degree (or equivalent) , OR
- ✓ For Undergraduate Your selected exam window must be 23 months or fewer before your graduation month for your bachelor's degree or equivalent program, OR
- ✓ Have a combination of 4,000 hours of work experience and/or higher education (does not have to be investment related)

Have a valid international travel passport (required for exam registration and admission to the test centre).
