## Step 1: Become the CFA Program Candidate

The entrance requirements for CFA Program candidacy:

- ✓ Have a bachelor's (or equivalent) degree, OR
- ✓ Be in the final year of your bachelor's degree programme at the time of registration, OR
- ✓ Have four years of professional work experience (does not have to be investment related), OR
- ✓ Have a combination of professional work experience and education that totals at least four years. Part-time positions do not qualify, and the four-year total must be accrued prior to enrolment.

Have a valid international travel passport (required for exam registration and admission to the test centre).
